Most customers purchase them for \$4/box, but the bulk of the profits (\$2.90-\$2.50/box) benefit Councils, which GSUSA allows to partner with pro-abortion and gay-promotion groups. Therefore, out of \$700 million in sales (175 million boxes), each girl earns an average of \$25 but Councils rake in roughly \$490 million to spend without regard to members' wishes. That's a pretty good profit from a free, child labor force that includes 5-year-olds.
